The motion was seconded by Treasurer Cholcher and carried unanimously (4-0).

3. Marconi and Debra Faia request to relocate water meter <u>Recommended Action:</u> Listen to request and direct staff <u>Public Comment:</u> **Public comment was received**

<u>Board Action:</u> Director Bell made a motion directing staff to present a cost estimate for the construction of a water line to the property in question and to research district minutes for information regarding the movement of the original meter for the property in question. The motion was seconded by Director Cochran and carried unanimously (4-0).
